## EASTON BOARD OF SELECTMEN PUBLIC HEARING/REGULAR MEETING 21 OCTOBER 2019 7:00 PM MINUTES

During the Manager's Report, Town Manager Gardner stated that Ryan Gundy had been hired to replace Dwight Flewelling as maintenance man for the Town facilities. Town Manager Gardner inform the Easton Board of Selectmen that he would be applying for a LED replacement grant for lighting at the Town Garage and Municipal/Fire Department

building. Town Manager Gardner stated that the following items were ongoing projects: Easton Planning Board will be meeting on 6 November 2019 to finalize the Village Acres Sub-division plan and then will have the plan recorded, Presitle Community Park project has grown to a budget of \$273,429.00 and the grant should be completed by 15 November 2019 with a submittal date do by the 22 November 2019, Town Salt/Sand she extension project is now in the design stage with a design completion date of 31 January 2020, at that point the addition will be put out to bid for the 2020 Town Meeting warrant, Town Manager Jim Gardner will be taking vacation from 24 October 2019-1 November 2019, Municipal departments will be starting the 2020/2021 Municipal Budget, first looking at Capital Improvement Projects and finally there are three buildings in the community that are deemed dangerous buildings or nuisances that need to be addressed by the Easton Board of Selectmen.

Selectmen Dudley made the motion to inform the Code Enforcement Officer of the three buildings of concern (155 Station Road, 149 Center Road and 250 Richardson Road) and to take all legal actions through the Town Attorney to remediate the dangerous and nuisance buildings. Selectmen Blackstone seconded the motion. Motion carried 5-0.

There were no Selectmen Items.

Selectmen Flewelling made the motion to adjourn at 9:25 pm. Selectmen Allen seconded the motion. Motion carried 5-0.
